**GENERAL CONDITIONS:**

- The position is purely temporary on Contract basis initially for a period of one year and may be curtailed or extended by one more year subject to the evaluation of performance of the candidate by the Competent Authority.** The contract may be terminated at any time by giving one month's notice by either side. The applicant(s) will have no claim implicit or explicit for consideration against any CSIR/CECRI post.
- Eligible candidates may appear for the walk-in-interview with original certificate(s) and application form duly filled in together with a recent passport size photograph, self-attested copies of SSLC/HSC/Bachelor of Physiotherapy Degree Certificate (s) and Marks Statement for all the Semesters/Years, SC/ST/OBC certificate(s) and other testimonials in support of Date of Birth, Qualification, Experience and Community etc. The Application form may be downloaded from CSIR-CECRI Website: [www.cecricri.res.in](http://www.cecricri.res.in)
- In case candidate is having his/her own physiotherapy centre registered under the Clinical Establishments (Registration and Regulation) Act, they may have to submit their experience certificate in their letter head and the physiotherapy centre registration number with a copy of the physiotherapy centre registration certificate.
- If any selected candidate provides any false information, his/her candidature is liable to be rejected.
- Compulsory Rotatory Residential Internship (CRRRI) certificate.
- Experience certificate/ Documents issued by the Employer in support of experience.
- Certificate of registration with State Physiotherapy & Occupational Therapy Council (or) Indian Association of Physiotherapy.
- Candidates should ensure that they submit all the documents mentioned above. In the event of failure to submit any of the required documents as mentioned above within the stipulated period, **Candidature is liable to be rejected.**
- Candidate shall not photograph/record any proceedings of the interview through any form. In case of any such activity found at later stage, his/her candidature for the post applied will be summarily rejected without prejudice to taking actions under extant laws governing such malpractices.

10. In case of Universities/ Institute awarding CGPA/ SGPA/ OGOA grades ect., candidates are requested to convert the same into percentage based on the formula as per their university/ institute (copy of documented proof of the conversion factor must be attached).
11. It is the responsibility of the candidate to ensure his/her own eligibility for the post for which he/she has been selected in accordance with the advertisement. In case, it is detected later at any point of time, in future, even after appointment the candidate is not eligible as per prescribed qualification due to whatever circumstances, his/her candidature/appointment shall be liable to be cancelled/terminated as the case may be and no appeal against such cancellation will be entertained. Mere selection does not confer any right for permanent appointment in CSIR – CECRI.
12. No TA/DA will be paid to the candidates appearing for the Interview.
13. The decision of the Director, CSIR-CECRI in all matters relating to eligibility, acceptance or rejection of applications and mode of selection will be final and binding on the candidates. No enquiry or correspondence will be entertained in this connection.
