CSIR – Central Food Technological Research Institute, Mysuru a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of 1 (One) position of Project Assistant (Level-II), initially for a period of **one year** or till the project is over on a temporary contractual basis in the project entitled **“Non-thermal processing of liquid foods” (MLP-0204)**, at the Food Engineering Department, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications:

First class B.Tech./B.E./M.Tech. in Food Engineering/Food Technology/Chemical Engineering with good academic records. Candidates having research experience in relevant field and GATE/NET qualification will be given priority.

Emoluments:

Rs. 25,000/ per month (Rupees Twenty Five Thousand only) consolidated.

Terms and Conditions:

1. Candidates should not have exceeded **30 years** of age as on **23.01.2017** i.e. the last date of receiving the applications. Age relaxation as applicable by Gov. of India rules for SC/ST/OBC and women candidates will be considered.
2. The engagement of PA-II is exclusively for the above mentioned research work.
3. The engagement will be contractual and on purely temporary basis for a maximum period of one year or co-terminus with the project, whichever is earlier.
