#### EMPLOYMENT NOTIFICATION No: CMRL/HR/CON/03/2023 dated 25-01-2023

Chennai Metro Rail Limited (CMRL), a Joint Venture of Government of India and Government of Tamil Nadu, is a special purpose vehicle (SPV) entrusted with the responsibility of implementing the Metro Rail Project in the city of Chennai.

CMRL invites applications from qualified and experienced personnel for the appointment of undermentioned posts. :-

#### Note: -

- (i) Age, qualification & experience stipulated for above posts should be as on <u>25-01-2023</u>. Age will be relaxed for deserving and experienced candidates.
- (ii) Selected candidates on contract appointment may be considered for IDA Pay Scale on contract basis subject to satisfactory completion of 2 years contract period, depending upon the requirement of CMRL and performance of the candidate. Applicants, who are applying through proper channel from Govt./ PSU's with minimum 2 years in regular pay scale may be considered for IDA Pay on contract basis directly on selection, as per the existing terms and conditions of CMRL policy.
- (iii) Higher remuneration / Higher post shall be considered based on the past experience, performance in the interview, higher qualification, exceptional credentials and expertise in the relevant field.
- (iv) Apart from the consolidated pay, benefits like Medical & Personal Accident Insurance, Life Insurance, Mobile Phone reimbursement & Sim Card for official use and other admissible allowances as per the extant rules of CMRL HR policy shall be paid.
- (v) For Deputation post: The candidate should apply through proper channel as per the terms and conditions stipulated vide Employment notification <u>No.CMRL/HR/DEP/02/2023</u> dated 25-<u>01-2023</u>. Therefore the candidates are advised to refer the said deputation notification.

#### 1) <u>Required Qualification and Experience:-</u>

#### a) <u>i. Chief Vigilance Officer - (01 Post) - On Deputation basis:-</u>

- Must be an Officer belonging to Organized Group-A Services drawing pay in the scale of Senior Administrative Grade (SAG) in their cadres (Functional/Non Functional)
- The officer having experience of working in technical disciplines of Group A engineering disciplines of railways will be preferred.
- The Bench Mark for selection would be at least '8.0' in the APAR Grading of the last 5 years and the integrity should be beyond doubt. (Wherever number grading is not available 'Very Good' will be acceptable)
- The officer having experience in handling various preventive and punitive measures in detection, punishment of corruption and other malpractices are preferable.

#### ii. Scale of Pay:

The deputationist shall have option either to draw pay being drawn in the parent organization with deputation allowance and project allowance at 10% of Basic Pay each.

(or)

To draw equivalent cadre IDA pay scale in CMRL with IDA, HRA and Cafeteria Allowance (20% of Basic Pay).

#### iii. Tenure of deputation:

Initial period of deputation will be for a period of 3 years, which may be extendable upto 5 years .

#### b) Post Code No. 01 - General Manager (P & BD) - (01 Post) - On Contract basis:-

Must be a graduate from a recognized University/Institute with a MBA degree in Marketing/Finance. The candidate should have minimum 20 years of post-qualification experience in Business Development/Property Development in Urban Transport sector. An experience in Metro Rail projects/undertaking similar kind of large scale infrastructure development projects and managing a large portfolio of developed properties will be a desirable attribute. The responsibility of the candidate will be to manage the extensive Property Development

program of CMRL, so as to maximize the non-fare revenue innovatively from property development. He will also be responsible for planning Mass Transit Infrastructure till the stage of approval cum funding.

#### Job responsibilities

- He/She shall be responsible for overall planning and property development (Non fare box revenue) related activities for CMRL.
- Monitoring and management of all Business Development (BD) related activities such as licensing of kiosk/retail spaces, Advertisements, small and large scale developments, Telcom related business, etc.
- Monitoring and management of Non-Fare box revenue streams including enhancement of non-fare revenue.

- Monitoring and management of all Property Development (PD) related activities such as small and large scale developments including land parcel development.
- Undertake assessment of Multi modal integration plans with associated infrastructural facilities, etc.,
- Monitor transport and other relevant sectoral policies, government orders, notifications and private sector developments to coordinate work and Liaise with other departments within CMRL and with CUMTA, MTC and other public agencies and government bodies at the city level.
- Preparation of feasibility/Detailed Project Reports for implementation of Mass Transit Systems, including project approvals and funding tie ups.
- Explore innovative opportunities and provide insights on areas for future projects, opportunities and challenges for connectivity.
- Collaborate with other departments, NGOs, Research Institutes and Government bodies at the city level.
- Prepare technical reports, policy notes, presentations, and other documentation materials.

#### C) <u>Post Code No. 02 - Additional General Manager (Contract Procurement) (01 Post) - On</u> <u>Contract basis:-</u>

#### i. Qualification: -

Must possess B.E/B.Tech (Civil/Mech/ECE/EEE) degree from a Govt. recognized Institute / University approved by AICTE / UGC.

#### <u>ii. Experience: -</u>

- Should have minimum of 17 years of post-qualification experience in procurement field in Metro/Railways/Large infrastructure projects.
- Should have experience in the fields of contract procurement for various types of contracts such as works, consultancy, service and system contracts related to metro/Railways/Large infrastructure including experience in FIDIC contract procedures, Multinational Bank Procurement procedures, Formulating tender and contract conditions etc. evaluation, finalisation and experience in e-tender procurement.
- The candidate should have good knowledge of FIDIC Suite of Contracts, operations of the clauses. Should have handled bid preparation and floating of tenders under MDB or external funding under bilateral agreements, should have hands on experience in implementing e-tendering.
- Should have thorough knowledge on modalities for inviting bids, tender openings, CVC guidelines, statutory taxation/levies etc.
- Experience in GeM portal (Government e-Marketplace) is desirable. Should be conversant with Government eprocurement guidelines and procedures & policies for procurement of goods & services.

#### 2) <u>Selection process:</u>

The selection methodology comprises two-stage process, interview followed by medical examination. The selection process will judge the candidate on different facets like knowledge, skills, comprehension, attitude, aptitude, and physical fitness.

# Medical Examination:

Expenses for the first-time medical examination of the candidate will be borne by CMRL. However, in case a candidate seeks extension for joining, then the second time medical

examination expenditure will be borne by the candidate. To & fro travel expenses for the medical test shall be borne by the candidate. The candidate who fails the prescribed medical test will not be given any alternative employment and decision of CMRL is final on this issue.

#### 3) <u>Character & Antecedents:</u>

The success in the above stated selection process does not confer any right to appointment unless CMRL is satisfied after such an inquiry, as may be considered necessary, that the candidate's character and antecedents is suitable in all respects for appointment to the service.

#### 4) <u>Concessions & Relaxations:</u>

 a. The age limit prescribed shall be increased by five years in respect of candidates belonging to Scheduled Castes or Scheduled Caste (Arunthathiyars) or Scheduled Tribes and two years in

respect of candidates belonging to Most Backward Classes/ Denotified Communities, Backward Classes (other than Muslim) or Backward Classes (Muslim).

- b. A Differently Abled Person shall be eligible for an age concession up to ten years over and above the age limits prescribed for the notified post by direct recruitment only, provided the applicant is otherwise fully suitable and the disability is not such as would render him incapable of efficiently discharging the duties w.r.t post for which the candidate is selected.
- c. The upper age for Ex-Servicemen will be prescribed age limit plus the length of service in armed forces plus 03 years.

# 5) <u>Payment of application fee for Contract type of appointment only (including postage/other charges) (Non-refundable):</u>

a. - b. Candidates should clearly mention their name, postcode and mobile number at the back of the Demand Draft. No application fee for Differently Abled persons. Only disability certificate to be attached along with the application.
- c. Fee once paid will not be refunded under any circumstances. Candidates are therefore requested to verify their eligibility and time limit before paying the application fee.
- d. Application forms forwarded without submission through online careers page of CMRL and Demand Draft will be summarily rejected.

#### 6) General Conditions:

- a. Only Indian Nationals need apply.
- b. Age, Qualification & experience stipulated above should be as on <u>25-01-2023</u>. The candidates before applying are advised to ensure that they fulfill the eligibility criteria and

other requirements mentioned and that the particulars furnished by them are correct in all aspects. In case, if it is detected at any stage of recruitment process that the candidate does not fulfill the eligibility criteria and / or does not comply with other requirements of this advertisement and / or the candidate has furnished any incorrect or false information or has suppressed any material fact, the candidature is liable to be rejected. If any of the above shortcomings is / are detected even after appointment, the services will be terminated without any notice.

- c. The contract period is initially for a period of 2 years and the same will be extended for further period subject to the requirement and performance of the candidates as per the existing terms and conditions on mutual consent.
- d. In order to regulate the number of candidates to be called for interview, if so required, the management reserves the right to raise the minimum eligibility standards/criteria.
- e. Merely meeting the above qualifications and experience shall not entitle a candidate to be selected for interview. Only short-listed candidates will be notified for interview. CMRL reserves the right to shortlist the candidates. Acceptance or rejection of application of the candidates will be at the sole discretion of Management.
- f. Depending on the requirements, the CMRL reserves the right to cancel / curtail / increase the number of vacancies without any further notice and without assigning any reason thereof.
- g. Depending upon the response, the management reserves the right to increase or decrease the eligibility standards / criteria for the said post
- h. No TA/DA will be paid by CMRL to the candidates for attending the interview.
- i. CMRL reserves the right to withdraw the advertised posts at any time without assigning any reason and also reserves the right to fill either in the same position or at a lower position or not to fill the posts and CMRL decision in this regard shall be final.
- j. Persons already working in Government / PSU organization should apply through proper channel and produce NOC at the time of interview.

#### b. Step by step procedure to apply online application

**Step 1** - Candidate must register in CMRL Career portal by using a valid email id. The email id registered in the portal will only be used for any further correspondences from CMRL.

**Step 2** - A registration link will be sent to the registered email id. Therefore, candidates are required to click the verify button to authenticate their email id. Upon verifying, the user will be redirected again to the CMRL career page to log in and apply.

**Step 3** - Candidates are required to fill all details in each section and make sure to upload the requisite documents as per the specification, wherever applicable, in order to authenticate the details mentioned in the application form.

c. After submitting the application form through online in CMRL careers website, candidates are required to save & print the computer generated online application form, affix the latest passport size photo and should send the HARD Copy of the application form along with self-attested copies of educational qualification certificate, experience certificate, birth certificate, community certificate and other supporting documents through the forwarding authority to the below mentioned address on or before 24.02.2023.
