a. REQUIREMENT:

b. TENURE:

The initial engagement will be for a period of 2 (Two) years. Further, extension of engagement may be considered based on performance of the Visiting Consultant (Specialist Doctor) and requirement of the Division.

c. TERMS & CONDITIONS OF PART TIME ENGAGEMENT:

(i) The engagement of Part-Time Visiting Consultants (Specialist Doctors) will be purely temporary. The engagement as Visiting Consultant will not confer any right to claim the status of a regular employee of the Company under any circumstances.

- (ii) The Part-Time Visiting Consultants (Specialist Doctors) will not be entitled for any other Allowance or Benefits other than those indicated above. The engagement as Visiting Consultant will not confer any right to claim the Benefits / Facilities on par with regular employees of the Company at any time.
- (iii) The Part-Time Visiting Consultants (Specialist Doctors) will be governed by Rules & Regulations of their engagement in the Company. He/ She shall abide by the Rules and Regulations of their engagement at all times during the tenure of their engagement.
- (iv) The Part-Time Visiting Consultants (Specialist Doctors) will safeguard the security and confidentiality of all official matters and secrecy of information coming to their knowledge.
- (v) The Part-Time Visiting Consultants (Specialist Doctors) will be covered under the Income Tax, Service Tax, Professional Tax etc. as per the applicable rules. All such Taxes would be deducted from the remuneration payable to them.
- (vi) Part-Time Visiting Consultants (Specialist Doctors) are required to visit the Company Hospital on suitable days as per the requirements of the Organisation for providing treatment to the patients of the Industrial Health Centre, HAL, Koraput Division. The visiting consultants may be requested to attend emergencies at the IHC, HAL, Koraput Division.
- (vii) The part-time engagement is liable to be terminated by giving one month's notice in writing from either side or payment of consolidated remuneration equivalent to the amount payable for 5 visits. Further the part-time engagement will stand automatically terminated on completion of the prescribed tenure.

d. HOW TO APPLY:

- (i) Interested candidates shall forward the duly filled-in applications in the prescribed format in A4 size paper. The applications shall be forwarded along with the colour scanned copies of the Original Documents of proof of age, Educational Qualification along with the mark sheets, Relevant Experience Certificate, document of valid registration to practice and other relevant documents, if any, by email to recruitment.koraput@hal-india.co.in. Also, candidates shall forward a self-certified copy of all the scanned documents submitted. All the documents forwarded shall be in colour scanned and Portable Document Format (PDF).
- (ii) The applications along with the documents as mentioned above shall reach HAL, Koraput Division over email by **10-03-2023**, which shall be the last date for submission of applications.
- (iii) Candidature of applicants whose applications reach the Division after the last date for submission of applications will not be considered for interview.

e. **SELECTION PROCEDURE**:

- (i) Eligible interested candidates shall forward their application in the prescribed format along with the relevant documents by email to recruitment.koraput@hal-india.co.in by **10-03-2023**.
- (ii) Only shortlisted eligible candidates will be called for personal interview. The schedule of interview will be intimated to the shortlisted candidates via email only.
- (iii) Candidates shortlisted for interview are required to produce the relevant certificates / documents in original at the time of interview for verification.
- (iv) The interviews may be conducted in person or virtually over video conference mode. Candidates shall make necessary arrangements accordingly.
