**Vacancy Notification for Aircraft Technicians & Trainee Aircraft  
Technician on Fixed Term Contract Basis**

AI Engineering Services Limited (AIESL) is an Aircraft Maintenance, Repair and Overhaul (MRO) Organization, approved by DGCA (India) under CAR 145, to undertake MRO activities in India.

AIESL invites applications from Indian Nationals fulfilling the requirements as on 01<sup>st</sup> June 2024 for the post of Aircraft Technicians & Trainee Aircraft Technicians (B1 & B2) from the open market on Fixed Term Employment basis.

The selected candidates will be initially posted at Mumbai base of AI Engineering Services Limited (AIESL, MRO). Selection and empanelment do not guarantee that the candidate will be appointed immediately. Vacancy positions are tentative and may increase/decrease, depending upon the company's requirement. Release of candidates from the panel would depend upon the requirement of AIESL and decision taken by the Company in this regard. However the candidates may be transferred at any location of AIESL network based on the requirement of the company.

1. Duration of Contract : Fixed Term Contract would be initially for a period of 05 (Five) years and extendable for further period of 05 (Five) years depending upon requirement of the company and performance of the candidates.

\*Emoluments:

1. Aircraft Technician: Rs. 27, 940/- per month at the time of joining as per the approved salary structure of AIESL.

2. Trainee Aircraft Technician: Rs 15000/- stipend.

Trainee Technician: Candidate with experience of less than 1 year will be taken as Trainee Technician for a minimum period of 6 months. During the training period candidate will be paid stipend of Rs. 15000/-. On successful completion of training period and based on performance of the candidate, and as per the requirement of the company he/she may be absorbed as Aircraft Technician. The 5 years contract would be inclusive of 6 months training period.

\* Selection will be through the process of Skill Test/Trade Test and Technical Assessment & Personal Interview.

1. Application received will be scrutinized by AIESL.
2. Eligible/shortlisted candidate will be called for pre-interview formalities at notified time & date on the e-mail provided in the form.
3. Selected candidates based on successful interview will be informed to report AIESL & complete joining formalities at a later date.
4. Selected candidates will be required to undergo Medical test as per the advice of company medical officer. The shortlisted candidates will be inducted as per vacancies being decided to be filled in by the management subject to being found FIT in Pre – Employment Medical Examination.
5. Payment of application fees through Demand Draft is not valid and requests to consider the same will not be entertained.

- Applicants ordinarily domiciled in Kashmir Division of J & K State during 01.01.1980 to 31.12.1989 who are eligible for the upper age relaxation, must produce the Domicile Certificate to this effect at the time of Interview from the District Magistrate in the Kashmir Division, with whose jurisdiction the applicant had ordinarily resided or any other authority designated in this regard by the Government of Jammu & Kashmir.
- Indemnity Bond: The selected candidate would be required to submit a bond for a requisite amount as per company policy.



- Consideration of SC/ST/OBC/EWS/Ex-Servicemen candidates will be as per Government Directives of reservation of posts.
