Depending upon number of applications received candidates will be shortlisted for both written test and interview. Date, Time and Venue of test would be intimated to concerned candidates. Tentatively the written exam and interview may be held on 21st November 2025 at AIIMS Bhopal. When called, the candidates shall report for appearing in the interview and written exam with

- 2. Original and attested photocopies of all documents, certificates, degrees and mark sheets (Xth class onwards).
- 3. Copies of certificates/testimonials/documents/ detailed CV which the candidate may wish to bring to the knowledge of the selection committee.

#### **TERMS & CONDITIONS**

- 1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience.
