4. **Expiry of Contract:** The contract will automatically expire on completion of the period specified above until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
5. **Leave:** The leave entitlement of the appointee shall be governed by the AIIMS Bhopal leave policy governing extramural/short-term research projects as amended from time to time.

8. The prescribed qualification is minimum, and merely possessing the same does not entitle any candidate to selection.

The candidate should bring original certificates supporting his/her age, educational/professional qualification, experience, etc., two recent passport-size color photographs and one set of self-attested photocopies of the relevant documents, failing which he/she will not be allowed to participate in the Interview.
