**All India Institute of Medical Sciences, Bibinagar**, an Autonomous Institute of National Importance and apex healthcare Institute being established by the Ministry of Health & Family Welfare, Government of India under the **Pradhan Mantri Swasthya Suraksha Yojana (PMSSY)** with the aim of correcting regional imbalances in the availability/reliable tertiary healthcare services and to augment facilities for quality medical education in the country.

The term of engagement as visiting faculty under the visiting faculty scheme in the AIIMS Bibinagar are enumerated below:

1. Visiting Professor, Additional Professor and Associate Professor who are holding academic positions in Government Institutions within India or academic institutions outside India will be considered for visiting Faculty at AIIMS Bibinagar.
2. Faculty invited should be having professional recognition of eminence by work.
3. Visiting Faculty who have acquired medical degree from the five English speaking countries, namely, USA, UK, Canada, Australia and New Zealand recognized in India by MCI, would be allowed to take up assignment as per relevant provisions of the Medical Council of India. These doctors need only to get registered with the MCI or State Medical Council for taking up the assignment.
4. As per Section 14(1) of the Indian Medical Council Act, Medical Practitioners, with medical qualification acquired from Medical Institutions in countries with which there is no scheme of reciprocity available shall also be permitted to take up visiting faculty assignment in India in the institution of teaching research or charitable work, in consultation with MCI.
5. The visiting faculty would be involved for the purpose of engaging in teaching only. Where such faculty is required to do clinical work, this would be allowed only at the instance of the Executive Director of the AIIMS Bibinagar and with the prior permission of medical council of India (MCI).
6. Foreign national should have a valid visa and a valid medical travel insurance.
7. The rate of Honorarium is Rs. 6000.00/- (Rupees Six Thousand) per day for Professors and Rs. 4000.00/- (Rupees Four Thousand) per day for Additional Professor/ Associate Professor. Foreign

Faculty may be suitably equated with Professor/Additional Professor/ Associate Professor of Indian Institutes for this purpose.

8. The Executive Director is empowered to suitably fix the honorarium in specific cases, taking into consideration the professional standing and organizational position of the person, duration of assignment and any other relevant consideration.
9. The duration of the visit of the visiting Faculty may be for a period of four weeks and above and up to two years.
10. Visiting Professors would be entitled to and fro airfare in the following class at start/ conclusion of visiting program:
  - a) Professor/ Additional Professor-Business Class
  - b) Associate Professor-Economy Class
11. Suitable campus accommodation/ guesthouse facilities within the institute may be provided, subject to availability.
12. The number and sphere in which an external faculty is required to be invited would be decided by the Executive Director, AIIMS Bibinagar and in the manner deemed fit.
