#### Note:

1. As per guidelines EWS posts are not carried forward/or considered as backlog vacancy in case unfilled hence other category candidates may be allowed provisionally to apply for post subject to the condition that they will be considered for the post as an UR candidate only if EWS category seat is otherwise not filled.

2. 4% reservation for PwBD candidates on horizontal basis as per Government Rules.

#### **ESSENTIAL QUALIFICATIONS:**

#### 1. <u>SENIOR RESIDENTS (Non-Academic)</u>:-

- a) A medical qualification included in the first or second schedule or Part II of the third schedule to the Indian Medical Council Act 1956 (persons possessing qualifications included in the Part II of the third schedule should also fulfil the conditions specified in Section 13 (3) of the Act).
- b) Must be registered with the Central/State Medical Council.
- c) For Broad Speciality postgraduate degree i.e. MD/MS/DNB in the specialty concerned or its equivalent.
- d) For Super speciality, the essential qualification shall be MD/MS/DNB in related broad speciality or DM/M.Ch/DNB in concerned super speciality.

#### AGE LIMIT: Senior Resident

Age limit for post of SR is 45 years (relaxable by 5 years for SC/ST candidates and 3 years for OBC candidates).

In case of Physical Handicapped (OPH) candidates, age relaxation up to a maximum period of ten (10) years for General Category, Thirteen (13) years for OBC category and fifteen (15) years for SC/ST category candidates.

#### PAY SCALES: Senior Resident

In Pay Matrix (Level-11) with a minimum of Rs.67,700/- + NPA (for medical personnel) as per recommendations of the 7th CPC.

#### 2. APPLICATION FEES:

For General/OBC/EWS: Rs. 1,000/- + GST@ 18% (Total Rs. 1180) For SC/ST category: Rs. 800/- + GST@ 18% (Total Rs. 944) For PWBD category application fee is exempted.

Application fee is required to be remitted through online payment gateway available in the website i.e. www.aiimsrbl.edu.in The application fee is non-refundable. Online applications without fee shall be summarily rejected.

#### 3. PROCESS OF SELECTION:

The selection of Senior Residents will be done through-

- a) Written Examination (MCQ based)- 80% weightage
- b) Departmental assessment-20% weightage

### 4. DOCUMENTS TO BE PRODUCED IN ORIGINAL AT THE TIME OF DOCUMENT VERIFICATION:-

The Candidate should bring following original documents and one set of self-attested photocopies at the time of document verification in case of his/her selection:-

- i. Identity Proof (PAN Card, Passport, Driving License, Voter Card, Aadhar Card etc.)
- ii. Address Proof.
- iii. Certificate showing Date of Birth. (Birth Certificate/ 10th Certificate). No Age relaxation would be available to SC/ST/OBC candidates applying for unreserved vacancies.
- iv. Photocopies of PAN Card and Bank Passbook and four recent passport size photographs (At the time of Joining for only selected candidates)
- v. Registration with Medical Council of India /State Medical Council.
- vi. Experience Certificate (if any).
- vii. FMGE certificate conducted by NBE (For foreign graduate).
- viii. Attempt and Internship Completion Certificate.
- ix. Reservation category Certificate (OBC\*/SC/ST/PH) (\*Candidate should belong to noncreamy layer of Central List of OBC in Government of India format).
- x. In case of OBC & EWS candidate, the OBC& EWS certificate must be issued within one year (Older certificate not be entertained).

- xi. Candidates working in Government Institution are required to submit "No Objection Certificate" from their present employer.
- xii. Class 10th & 12th Mark sheet and Certificates.
- xiii. Qualifying degree
  - a. MBBS Marksheet and degree certificates.
  - b. MD/M.Ch/DNB/MS or equivalent degree certificate.

Candidates who do not produce the above mentioned original documents at the time of documents verification shall not be offered appointment even though if he/she is selected on the basis of examination and Departmental assessment.

#### **General Conditions**

- 1. The aspiring applicants satisfying the eligibility criteria in all respects can submit their online application form through the link provided in the Institute website www.aiims.rbl.edu.in on or before 18<sup>th</sup> October 2023 till 5:00 P.M.
- 2. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the aforesaid post and must fulfil all the eligibility criteria on or before the last date of submission of form i.e. **18<sup>th</sup> October 2023** failing which their application will be rejected.
- 3. The duly filled on-line application form with all requisite documents and proof for deposit of fee must be submitted before the last date through online form submission link only. There is no need to send hard copy to the Institute. However, the documents mentioned at Sl no.4 (Documents to be produced) on pre-page must be uploaded with the application form and original set along with one self-attested phone copies of each document must be brought at the time of document verification.
- 4. The Executive Director, AIIMS, Raebareli reserves the right to increase or decrease the number of Senior Resident posts depending upon the vacancy situation at the time of Written Examination/Departmental Assessment.

- 1. The appointment is initially for a period of One (01) year, which may extendable up to three (03) years based on performance & conduct and on the discretion of the competent authority of the Institute.
- 2. The leave entitlement of the appointee shall be as per the Central Residency Scheme and Institute Policy.
- 3. The appointee shall perform the duties as assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional remuneration will be admissible in case of such assignment.

- 4. The Competent Authority reserves the right to change the number of vacancies, withdraw the process in full or in part and also the right to reject any or all applications received without assigning any reasons or giving notice etc.
- 5. The appointment to the said post will be subject to medical fitness from the competent Medical Board for which he/she will be sent to the designated Medical Authority of the Institute.
