- 1. Contribute to the State newborn AMR consortium as needed and suggested by the supervisor.
- 2. Facilitate Data Collection, Compilation, Analysis, and review related to the project area.
- 3. Regular coordination with District teams to promote quality and timely data support.
- 4. Field level Supportive supervision/hand-holding to ensure timely and standard data-based operations, as per project need.
- 5. Do daily tele-round of 10 SNCU.
- 6. Help the P.I. in the condition of training on Q.I, ETAT/HDU, and newborn Care.
- 7. Analyze the data, identify the gaps, and facilitate for implementation of suggestive inputs to get the optimum quality data outputs.
- 8. Coordination with different stakeholders for implementation of project interventions.
