Applications are invited from eligible candidates to work on the following post(s) on a contract basis in a research project funded by an external agency at the All India Institute of Medical Sciences, Rajkot, as per the details below:

**Project title:** “Setting up of Nation-wide Network of Laboratories for Managing Epidemics and National Calamities.”

**Funding agency:** Department of Health Research – Indian Council of Medical Research (DHR-ICMR).

**Duration of employment:** Initial appointment will be for twelve months which can be extended further depending upon the candidate's performance, continuation of scheme and budget grant from the funding agency.

#### Age Relaxation:

Age limit is relaxable for SC/ ST candidate for a maximum period of five years. In the case of OBC candidates it is relaxable upto maximum period of three years. In the case of Persons with Disabilities (PwBD) candidates, this is relaxable upto maximum period of ten years for General category, thirteen years for OBC category and fifteen years for SC/ST category candidates.

## SELECTION PROCESS

- The applications received will be scrutinized by the screening committee.
  - Mode of selection-
- (a) **For Research Assistant**  
**Interview only** - A written test may be conducted only if number of eligible candidates are more than 30 to shortlist candidates for interview.
- (b) For Laboratory Technician and Multi-tasking staff  
**Written exam/skill test followed by interview** - The **interview shall be conducted for up to six (6) candidates per available post** who secure the **highest marks in the MCQ-based written test**. The relative weightage of written exam and interview will be 80% and 20%, respectively for determining the final merit.
- Candidates appearing for the interview must possess the above-mentioned documents **in original** at the time of reporting for written exam/interview.
  - Selection is based purely on merit.

## TERMS AND CONDITIONS:

1. The position(s) are purely on contract basis for an externally funded research project, and the person engaged will have no claim to any regular post in AIIMS Rajkot at any time or continuation of his/her service in same or any other project.
2. A separate application should be submitted for each post, if applying for more than one post.
3. The number of posts may be increased or decreased as per the directions of the funding agency and the requirements of the project.
4. The Crucial/ cut-off date for determining eligibility (Age/ Educational qualification/ Experience) shall be last date of submission of application.
5. Qualification and experience should be in a relevant discipline/field and in a recognized institution/organization. The experience should have been gained after acquiring the essential qualification.
6. Qualification, experience, other terms, and conditions may be relaxed/ altered at the discretion of the Principal Investigator.
7. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. Submission of wrong or false information at any stage during the process of selection or canvassing of any kind will lead to disqualification or even termination if detected after the person has been engaged.
8. Mere fulfilment of the essential qualification/experience does not guarantee selection. The decision of the selection committee regarding selection of candidates will be final and no representation will be entertained in this regard.

13. No TA/DA will be paid for attending the interview.
14. Duration: The assignments are purely temporary for a period of 12 months. The duration of employment may be extended or curtailed at discretion of the Principal Investigator.
15. Expiry of Contract: The contract will automatically expire on completion of the stipulated time or earlier in case of withdrawal of support by the funding agency. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.

16. The candidate appointed will not be considered as regular employee of AIIMS Rajkot or Government of India and will not be entitled for any other financial/non- financial benefits /facilities, or any special allowances other than the fixed consolidated emoluments prescribed by the funding agency.
17. The House Rent Allowance (HRA), if admissible as per the funding agency's guidelines, shall be paid for the classification of Rajkot city (Class 'Y').
18. Leave: The leave entitlement of the appointee shall be governed by the Leave Policy of AIIMS Rajkot for project staff, as amended from time to time.
19. Accommodation: No hostel or any other accommodation will be provided by the institute.
20. The roles and responsibilities of the appointee shall be in accordance with the funding agency guidelines and as assigned by the Principal Investigator from time to time.
21. The project staff will normally be posted at the study site; however, he/she may be temporarily posted to other study sites in the interest of project work.
22. Selected candidates may have to work in shifts/night duty as and when required. Staff may have to go on field visits and travel outstation for any need under the project.
