

Candidates meeting the age criteria and possessing the required qualification, experience, etc. and willing to work for the above-mentioned projects may apply and fill the Application Form in the prescribed format only. There is no need to send hard-copy of any application form/documents at this stage.
2. Late and incomplete applications or applications not submitted in the prescribed format will not be considered.
3. The above position will be filled purely on temporary **CONTRACT** appointment basis.
4. The rates of emoluments/stipend shown in this advertisement are as per the guidelines and as per the sanction.
5. Cut-off date for age limit will be the date of Walk-In-Interview i.e. date of interview.
6. Age relaxation is admissible in respect of SC/ST/OBC/PWD candidates as per government rules.
