**Terms & conditions:**

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. Any misinformation detected at any stage will make the candidate liable for legal action. Permission to appear in the selection process does not approve the eligibility of the candidate. Even after qualifying the selection process the candidate may be rendered disqualified at the time of document verification if he/ she does not fulfill essential eligibility criteria
2. Eligibility criteria and age cut off for various posts are as per table. Note: Cut-off-date for age limit will be as on last date of submission of application. Age relaxation for SC/ST/OBC candidates shall be as per GOI norms. (The validity of non-creamy layer certificate should be issued for the financial year 2025-26, issued on or after 01<sup>st</sup> April 2025).
3. The engagement of the above posts will be contractual and purely on temporary basis for a period of 11 months with one day break, followed by extension for another 11 months (extendable based on satisfactory performance review till project completion, whichever is earlier).
