The University intends to hold a Walk-in-Interview for empanelment of Guest Faculty in the discipline of Traditional Indian Art Forms, Literary Art etc. on **28.02.2025** at **School of Culture and Creative Expressions (SCCE)**, Dr. B.R. Ambedkar University Delhi, Lothian Road, Kashmere Gate Campus, Delhi – 110 006.

Interested eligible candidates are required to register himself/ herself on 28.02.2025 at 09:00 AM to 11:00 AM in the School of Culture and Creative Expressions (SCCE) with all their original certificates/ mark sheets with an attested photo copy of each of it and a recent passport size photograph along with the updated Bio-data. No TA/ DA would be provided for attending interview. The candidates not fulfilling eligibility criteria would not be considered for selection process.

The applicants who have applied for the post of Guest Faculty (Literary Art/ Creative Writing) at the level of Assistant Professor, against the advertisement No. AUD/12/Acad./2024 dated 20.12.2024 may also attend the Walk-in-Interview on above mentioned scheduled.

The panel will be valid for one year, however, validity of panel may be extended till completion of ongoing Semester, if required. The candidates will be engaged for teaching assignments from the panel as per merit list of the panel after assessing the teaching load during the semester to meet the shortfall of teachers in University due to their long leave or due to requirement of additional teachers for introducing a new course etc. The candidate will be engaged from the panel in the following categories:

The Literary Art/ Creative Writing Programme is a practice Programme and requires literary practitioners interested in and committed to creative writing pedagogy among its faculty. The School/ Programme, therefore, welcomes applications from creative writers along with those trained in literature.

The vacancy may increase or decrease as per the requirement during the validity of the panel. The engagement out of the panel of eligible candidate and qualified candidate may be made on contract basis, if the situation so arises and the emolument shall be related as per UGC/ AUD regulations.

Essential Qualifications as per UGC Regulation 2018

- i) Master's Degree with 55% marks (or an equivalent grade in a point scale wherever grading system is followed) in the relevant subject or an equivalent degree from an Indian/foreign University.
- ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M. Phil. / Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be.

Provided further, candidates registered for the Ph.D. Programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / Bye-laws / Regulations of the Institutions awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:

- a) Ph.D. degree has been awarded to the candidate in a regular mode

- **B.** A traditional or a professional artist with highly commendable professional achievement in the subject concerned having a Bachelor's degree, who has:
- i) studied under a noted/reputed traditional Master(s)/Artist(s)
- ii) Has been 'A' grade artist of AIR/ Doordarshan;
- iii) Has the ability to explain, with logical reasoning the subject concerned; and
- iv) Has adequate knowledge to teach theory with illustrations in the discipline concerned.

B. Age:

The superannuated teachers may also be considered for engagement as Guest Faculty subject to a maximum age limit of 70 years.

C. Honorarium:

The Honorarium for Guest Faculty as per entitlement i.e. Rs.1500/- per lecture subject to a maximum of Rs.50,000/- per month as per UGC norms.


Guest Faculty will not be treated like regular teachers for the purpose of voting rights or for becoming the members of the various statutory bodies of the University.

The Guest Faculty will not be given the benefit of allowances, pension, gratuity and leave etc. as admissible to the regular teachers.

Other Instructions:

- The recruitment shall be made in accordance with the UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2018.
- 2) In accordance with the UGC Regulations, 2018, as amended from time to time along with AUD Acts, Statues and ordinances, including amendments made thereafter, applicants applying for the post of Guest Faculty at the level of Assistant Professor must submit a certificate in the prescribed format as per Annexure I & II (as applicable) from the concerned University to the effect that their Ph.D. degree is in compliance with relevant UGC Regulations for award of Ph.D. degree.
- 3) Interested candidates are requested to bring self-attested copies of the following documents along with originals (original will be returned after verification):
 - a) Valid Non Creamy Layer OBC (Delhi) certificate issued from the Competent Authority of Government of National Capital Territory of Delhi for the Financial Year 2023-24. Candidate who does not produce the required OBC (NCL) certificate valid for the FY 2024-25, shall not be allowed for interview.

 - c) Copies of your publications which you may like to present before the Selection Committee.

- 8) The assessment shall be based on evidence produced by the applicant such as: copy of publications, project sanction letter, utilization and completion certificates issued by the University and acknowledgements for patent filing and approval letters, students' Ph.D. award letter etc.
- 9) Relaxations as per UGC Regulations, 2018 on the Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education,
 - i) A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Schedules Caste/Scheduled Tribe/Other Backward Classes(OBC)(Non-creamy Layer)/ Differently abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e)Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of the eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualification marks without any grace mark procedure.
 - ii) A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders, who have obtained their Master's degree prior to 19th September, 1991.
- 10) Applicants serving in Government/Public Sector Undertakings (including Boards/Autonomous Bodies) are required to submit 'No Objection Certificate' on the prescribed proforma from the employer, at the time of interview.
- 11) Any addendum/ corrigendum, if any, shall be posted on our university website http://aud.ac.in/careers only.
- 12) The University reserves the right to revise/reschedule/cancel/suspend/withdraw the recruitment process in part or full without assigning any reason. The decision of the University shall be final and no appeal in this regard shall be entertained.
- 13) In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issuing an appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the applicant in this regard.
- 14) In case of any dispute/ambiguity that may occur in the process of selection, the decision of the University shall be final.
