7. No TA / DA will be provided to attend the interview.



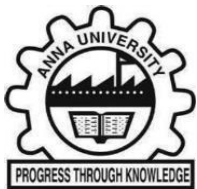
