1. **General Instructions:**-

- (a) Date of determining eligibility in terms of Age will be **last date of submission of online application**.
- (b) The link for submission of online applications in respect of aforesaid posts alongwith other relevant information will be activated on the date of publication of the advertisement in Employment news/Rojgar Samachar, Indian Express (English) and 'Sakal' (Marathi) newspaper or earlier (as posted on the website).
- (c) The last date of online submission of applications will be 21 days (till 11:59 PM) from the date of publication of this advertisement.
- (d) Only online applications will be accepted. Applications received by post/ by hand/ by mail etc. will not be accepted. The decision of the Competent Authority of AFMC, Pune & AFMSD, Pune in this regard will be final. No correspondence will be entertained in this regard.

2. How to Apply:-

- (a) The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling eligibility criteria as on the last date of submission of application failing which their application will be rejected. They must possess the educational qualification as recognized by the Govt of India. Their candidature will be cancelled at any stage if it is found that their educational qualification is not recognized by the Govt of India.
- (b) The aspiring applicants satisfying the eligibility criteria in all respects can apply through online application mode only. The online registration of application will be made available on official website of AFMC Pune www.afmc.nic.in and on https://www.eenroll.in/. The date of activation of link for submission of online applications in respect of aforesaid posts along with other relevant information will be notified on the website.
- (c) Candidates are advised to fill their valid Email ID in the online application, as all correspondence will be made by the Institute through Email.
- (d) On successful e-registration of candidate, confirmation email and SMS will be forwarded to the candidate by CIPL for verification.

- (e) The candidate must ensure that their photograph, signature and thumb impression should be clearly visible in preview at the time of online application. So, candidates are advised to be careful while uploading their photograph and signature.
- (f) All the supporting documents i.e. educational qualification, valid EWS Certificate identity/ address proof including online application form is required to be sent through online mode only. - **4. Reservation:-** The vacancies advertised under EWS Category are as per the instructions issued by DoP&T, Ministry of Personnel, Public Grievances & Pension, Govt of India, vide OM No. 36039/1/2019-Estt (Res), dated 31.01.2019. Candidate who fails to produce valid EWS certificate will not be considered for reservation under this category. They will however, be considered under UR category.
- **5. No Objection Certificate (NOC):-** The applicant, already in Central Government service (including AFMC, Pune & AFMSD Pune) shall have to upload "No Objection Certificate" issued by their present employer/competent authority at the time of filling of Online Application. Further, it is mandatory to produce the same NOC at the time of Documents Verification if shortlisted.

6. Method of Selection:-

- (a) Selection in any post mentioned in this Advertisement will be made on the basis of Computer Based Test (CBT). Question Paper of written exam for 10th level posts will consist of 100 x Multiple Choice Objective type questions and will be in both English & Hindi, except Part C. There will be no negative marking for wrong answers. The correctness or otherwise of the answers shall be decided based on the pre-set key of answer and no representation in this regard will be entertained. The duration of the CBT will be 90 minutes.

(c) Final appointment order will be issued based on merit cum choice. The selected and reserved candidates will be called for giving their choice after preparing the merit list.

7. Other terms and Conditions:-

- (a) Date of Online CBT Examination will be intimated later on AFMC Pune website **www.afmc.nic.in** and on **https://www.eenroll.in/**
- (b) The centre for Online CBT Examination will be communicated to the candidates in due course.
- (c) No TA/DA will be paid for appearing in the Online CBT Examination.
- (d) Selected candidate will be subjected to all India Service liability.

- (e) The CBT Examination will be conducted simultaneously for both the post. Depending upon the number of candidates, the exam will be conducted in multiple shifts. In such cases, different set of question paper will be used for each shift and normalisation will be undertaken for calculation of result.
- (f) The decision of competent/ appointing authority regarding all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, mode of selection, methodologies for the selection, and allotment of posts to selected candidates will be final and binding on the candidates and no representations will be entertained in this regard.
