Applications are invited for the teaching engagements for the computer science and related subjects/courses for ASTU in-campus self-financing UG and PG Program(s) on temporary basis (mainly in the area of Computer Science and Engineering). The senior / retired professors may also apply. Teaching engagement will be for one semester, renewal for one more semester, with maximum duration of 11 months and at the level of appropriate level.

The applicants should possess the requisite qualifications and relevant experience as per latest UGC/AICTE guidelines applicable for University Faculty position at appropriate level.

When on active duty, the applicants will be paid the consolidated amount of remuneration ranging from Rs. 25000/- to Rs. 60000/- per month depending on expertise and experience. The university is not liable to pay any additional allowances / amount.

#### **General Instructions to the Candidates**

- 1. The engagement will be initially for one semester and may be renewed for one more semester with maximum duration of 11 months. The renewability after one semester will be based on the quality of teaching feedback in the courses taught in ASTU (at least two theory papers in a semester) and the candidates' general contributions as per UGC's guidelines for Self-Appraisal Report of teachers. No separate remuneration/honorarium would be applicable for the conduct of the in-semester continuous evaluations, end-semester final examinations for all UG as well as PG students, including doctoral students, and/ or any such evaluations as may be needed by the university. All such evaluations have to be completed in timely manner, in maximum 4 days times failing which the university may forfeit the consolidated remuneration and the candidate would not have any claim for the same. The candidate would undertake to sign a legal contract for effecting these (and other) terms and conditions, including the declaration that the candidate shall not claim anything whatsoever about employment/ post after the period of 11 months.
- 2. The engagement is to be made on purely temporary basis and services would be liable to be terminated without assigning any reason thereof. These are temporary basis engagements and terminable with 24 hours' notice.
