No other mode of application will be accepted.

- Eligibility Criteria:**

A. For ITI Trade Apprentices (Lineman & Electrician):

- The candidate must have passed 10th class examination with minimum 40% marks, from recognized Board and also possess National Trade certificate in the notified trade issued by the National Council for Vocational Training/State Council for vocational Training in respective trade.
- The candidate must have completed the relevant ITI course.
- The candidate must have Aadhaar Card(compulsory), which is required for online registration.

Note: There shall be No interview and no written exam.

- Selection Process:**

Eligible candidates shall be selected from the apprenticeship portal Database (NAPS/NATS). Selection shall be based on merit list prepared for all applicants. The merit list will be prepared on the basis of percentage of marks in matriculation 10th, and ITI course as per following details: -

ITI	30% to 10th class	70% to ITI in concerned trade	100

- Preference in Selection:** Based on merit criteria outlined in the advertisement, preference for selection of apprentices will be given as under: -

- 25% Seats out of total available seats for each trade will be given to candidates possessing the residency certificate of the concerned districts of the State of where the Grid Sub Station is located: -
 - Should the reserved seats still persist, then these seats will be given to the candidates possessing the residency certificate of the State where Grid Sub Station is located.
 - Should the above-mentioned reserved seats still persist; the remaining seats shall be filled through open Merit.
- Grid Sub-Stations area for O&M, Division, BBMB, Dhulkote that shall be considered are as under:**



i) District Ambala for 220 KV BBMB Dhulkote Substation, District Chandigarh for 66 KV Substation, Chandigarh, 400 KV TL Panipat, 220 KV TL Dhulkote, 400 KV TL Patiala, 400 KV TL Bhiwani, 400 KV TL Slapper.

In case of two candidates having the same marks, the candidate with older age shall be given preference.

C. In case the dates of birth are also same, then the candidates who passed matriculation exam earlier shall be considered first.

5. Reservation: Reservation shall be as per Apprentices Act 1961 and its amendments from time to time.

6. Age: As per Apprenticeship Act 1961 and its amendments from time to time.

7. Documentation: Short listed candidates shall be called for verification of following documentation: -

i. 10th Mark sheet.

ii. ITI Certificate & Marksheets (certificate should be duly Issued by NCVT/SCVT).


iii. Category certificate (SC/ST/OBC if applicable).

iv. Residence/Domicile certificate if applicable.

v. Aadhaar Card.

8. **General Guidelines:** Following guidelines are also to be considered:

- i. Candidates whose results are still awaited on the last date of receipt of applications for the qualifying examinations as mentioned in eligibility criteria will not be considered.
- ii. Selection and deployment of apprentices shall be subjected to detailed provision of Apprenticeship Act 1961 and its time-to-time amendments if any.
- iii. Result of engagement of apprentices shall be uploaded on BBMB websites through the office of System Software Manager, BBMB, Chandigarh.
- iv. Candidates, who after completion of their education have undergone apprenticeship training or undergoing apprenticeship training in any other establishment under Apprenticeship Act 1961, are not to apply for apprenticeship training.
- v. The selection and deployment of Apprentice Trainees will be subject to detailed provisions of Apprenticeship Act. The contracts with candidates thus selected will be registered under NAPS Portal. Therefore, candidates who have already been registered and got training under these schemes will not be entertained and need not apply.
- vi. The place of deployment for apprenticeship training shall be decided by the competent authority based on administrative requirements and the suitability of the candidate for area a under O&M Division, BBMB, Dhulkote. Therefore, requests for a specific place of posting are generally not considered.
