For candidates belonging to PwBD category having minimum 40% disability or more will get 10 years' relaxation in addition to the relaxation applicable to the categories mentioned above.

Terms of Engagement & Remuneration:

Project Engineer-I will be engaged initially for a period of Three years which may be extended up to a maximum of One year (including initial period) based on requirement and individual performance.
