- 4) The date of birth filled by the candidates in the application form and the same recorded in the Matriculation/Secondary Examination Certificate will be accepted for addermination and no subsequent request for change will be considered or
- 5) Certificate for the entire experience claimed, clearly mentioning the duration of employment (date, month and year), nature/duration of duties will be performed considered as the basis of eligibility.
- 6) Age relaxation: As per rules of Government of India from time to time
- 7) Schemes of Selection: -
- In case of large number of applications, shortlisting criteria will be adopted to limit the number of candidates to be called for written/ proficiency test.
- The selection process will include verification of candidates, verification of documents, skill/ proficiency test and written examination.
- All candidates have to appear for document verification along with photocopies and original documents in support of the claims made in their applications. 7.3
- The candidates who qualify the Document verification will be allowed to appear for the Skill/Proficiency Test. The Skill/Proficiency Test will be qualifying nature as per the prescribed qualifying standards.
- The candidates must obtain prescribed minimum percentage of marks fixed in the written examination. The merit list will be prepared on the basis of marks obtained in the written examination.
- Resolution of cases In cases where more than one candidate secures the equal aggregate marks, in written examination, tie will be resolved by applying the following procedure:
 - (i) Date of birth, with earlier born candidates placed at higher positions
- (ii) The candidates acquiring essential qualifications earlier will be senior.
