Central Silk Board (CSB), is a Statutory body established in 1948 by an Act of Parliament. It is working under the administrative control of Ministry of Textiles, Government of India, is engaged in undertaking, assisting and encouraging scientific, technological and economic research to improve levels of income in sericulture through spread of scientific sericulture practices to see India emerge as the leader in the world market for silk and advise the Central Government on development of silk industry.

1. <u>POST, PAY & ALLOWANCES</u>: CSB now invites online applications through CSB website http://csb.gov.in for recruitment to the posts of <u>Scientist 'B' (Pre-Cocoon Sector) in Central Silk Board, in Level-10 (7th CPC)</u> of the Pay Matrix (Pay Scale: Rs 56,100- 1,77,500) plus allowances as per Central Govt. Rules



2. QUALIFICATION:

ESSENTIAL QUALIFICATION: Master's degree in Science or Master's degree in Agricultural Sciences from a recognized University.

All applicants must fulfill the essential requirements of the post and other conditions stipulated in the advertisement. They are advised to satisfy themselves before applying that they possess at least the essential qualifications laid down for the post. No enquiry asking for advice as to eligibility will be entertained.

NOTE: The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for an Interview/Selection process.

3. AGE LIMIT:

Upper age limit is 35 years as on the closing date of receipt of online applications which is 05th September, 2024.

6. SHORT-LISTING BASED ON ICAR AICE-JRF/SRF(PH.D) - 2024 EXAMINATION SCORE:

The Short-listing of candidates for Personal Interview will be based on the valid score of ICAR AICE-JRF/SRF(Ph.D) – 2024 examination as mentioned in above disciplines. Short-listing of candidates for Personal Interview will be done in order of ICAR scores/marks obtained in ICAR AICE-JRF/SRF(Ph.D) – 2024 Examination. In case of tie, among two or more candidates having same marks, seniority in the merit will be decided based on age of candidates and the candidate being elder in age will be given higher seniority.

Personal Interview: Only the shortlisted candidates will be called for Personal Interview. Ratio for number of candidates to be called for interview will be decided by the Competent Authority. The candidates will be allowed to take part in the Personal Interview process only after successful completion of the Document Verification process. The date, time and venue of document verification & interview will be intimated on candidates registered e-mail. The same will be sent through sms also. The link for the call letter will also be hosted on CSB's website i.e. www.csb.gov.in.

Final merit list: Candidates shall be selected discipline/specialization wise on the basis of merit as **decided by the Selection Committee.** In case a tie occurs in the aggregate marks obtained, the seniority of candidate will be resolved based on age criteria, the applicant elder in age will be given high seniority in the merit list.

7. RESERVATIONS, RELAXATIONS AND OTHER CONDITIONS:

- 1. Reservations and relaxations for EWS / SC / ST / OBC (non-creamy layer) / ESM (Ex Servicemen) / PwBD (degree of disability 40% or above) candidates will be provided as per Government guidelines. Age relaxation will be applicable to vacancies against posts identified SC/ST/OBC (non-creamy layer)/PwBD.

- 3. Category (EWS/SC/ST/OBC/PwBD) once filled in the online application form will not be changed and no benefit of other categories will be admissible later on. Candidates are requested to take proper precaution while filling up the above details.
- 4. No Application fee will be charged from SC/ST/PwBD and female candidates during online registration in CSB.
- 5. The upper age limit is relaxed by 5 years for SC/ST, 3 years for OBC (Non-Creamy Layer) candidates. It is relaxed by 5 years for PwBD-Unreserved, 8 years for PwBD-OBC and 10 years for PwBD-SC/ST candidates as per the O.M. No. 15012/1/2003-Estt.(D) dated 29.06.2015 as per para 1 (ii) provision for recruitment to Group 'A' and 'B' posts otherwise than through Open Competitive Examination. In addition, the age relaxation for Ex-servicemen (ESM) will be as per Government of India norms.
- 6. Relaxation for Government servants and employees of Government autonomous bodies or Public Sector Undertakings upto 5 years in accordance with the instructions and orders issued by the Central Government. (Refer Annexure-II)
- 7. The OBC candidates who belong to "Creamy Layer" are not entitled for concession admissible to OBC category and such candidates have to indicate their category as Unreserved.
- 8. Candidates claiming benefits under OBC category shall be in accordance with castes notified in the Central List issued by the Competent Authority. The certificate should be in the Central List issued by the competent authority. The certificate should be in the prescribed format issued by

the competent authority empowered for the purpose. No other certificate will be accepted. (Refer Annexure-II)

- 9. Candidates seeking reservation benefits for SC/ST/OBC/EWS must ensure that they are entitled to such reservation as per eligibility. They should also be in possession of the certificate in the prescribed format in support of their claim as per format attached. (Refer Annexure-II)
- 10. Candidates belonging to SC/ST/OBC/ESW/ESM/PwBD have a right to compete with Unreserved Category Candidates against Unreserved vacancies. In such cases, no relaxation will be provided to the SC/ST/OBC/ESW/ESM/PwBD candidates. All documents to be self attested in support of educational qualification/technical qualification, experience and date of Birth to be enclosed with the application. (Refer Annexure-II)
- 11. Certificate issued for Non Creamy Layer OBC category should be valid as on the closing date for receipt of applications i.e. 05th September, 2024.
- Certificate issued on or after 01st April, 2024 for EWS category will only be considered valid for year 2024 and should also be valid as on the closing date for receipt of applications i.e. 05th September, 2024.
- 13. **Age Proof**: Date of birth filled in by the candidate in the application form and the same recorded in the certificate of matriculation examination will be accepted for determining the age and no subsequent request will be considered or granted.
- 14. Persons working in the Central/State Govt/PSU etc. must apply through proper channels along with the certificate from their establishment that no disciplinary action is contemplated/pending against them and that they have no objection in releasing them in case of selection. NOC covering above aspects must be issued on or after the date of publication of the advertisement otherwise it will not be accepted.
- 15. Merely fulfilling the basic conditions in the advertisement does not automatically entitle a person to be called for the Selection process.
- 16. All India service liability will be applicable for all selected candidates. Candidates once selected will be liable to service in Hard Areas/Hard Altitude Areas/Remote Locality Areas also. The candidates on selection will be subject to a probation period which will be subject to satisfactory performance of the individual during the tenure.

8. **HOW TO APPLY**:

- 1. The candidates need to apply in **online mode only** to CSB for the post of Scientist-B through the website www.csb.gov.in
- 2. Candidates should click on the "JOB OPPORTUNITIES" under CSB's website www.csb.gov.in They should keep ready their Information Bulletin for ICAR AICE-JRF/SRF(Ph.D) 2024 Score Card, Admit Card Application & Roll Number before applying as it is mandatory to fill the Score Card and Admit Card details.
- 3. Last Date for Receipt of Online Application: 05th September, 2024. No other mode of application shall be accepted.
- 4. Candidates belonging to Unreserved/EWS/OBC/Ex-Serviceman category are required to pay a non-refundable Application fee of Rs. 1000/- (Rupees one thousand only excluding taxes). The SC / ST / PwBD and female candidates **need not** pay the registration fee. There is NO Exemption for payment of fees in any other category.

5. Procedure:

- a. Candidate would submit the data online.
- b. He/ she would be prompted to upload the photo and signature
- c. Once completed, he/she would be prompted to generate the challan.
- d. Payment is to be made at any office of India Post (Bharatiya Dak), against the printed copy of the challan. Last date of payment of Fee is 06.09.2024.
- e. - f. The payment details would be updated on the online portal.
- g. Candidates would be able to download the application only if the payment details are updated which normally happens on t+1 day.
- h. In case of exempted candidates, the print application would be enabled as soon as he/she completes step (a) and (b).

- 7. Candidates shall read the instructions carefully and fill-in the online application from giving accurate information including INFORMATION BULLETIN FOR ICAR AICE-JRF/SRF(PH.D) 2024 AICE-JRF/SRF(PH.D) 2024 Score Card, Admit Card, Hall Ticket number and payment details. - 8. Fees once paid will not be refunded under any circumstances and no request will be entertained in this regard. Candidates are therefore requested to verify their eligibility before paying the Application fee.
- 9. Please ensure that the ICAR AICE-JRF/SRF(PH.D) 2024 admit card number and score card which is mentioned on your ICAR AICE-JRF/SRF(PH.D) 2024 score card and admit card, is filled correctly. Name should be entered as appearing in ICAR AICE-JRF/SRF(PH.D) 2024 admit card/score card.

9. INFORMATION AND INSTRUCTIONS:

- 1. Only Indian Nationals are eligible to apply.
- 2. All the educational qualifications should be from University/ Institution/ Board recognized by Govt. of India/ approved by Govt. Regulatory Bodies and the result should have been declared on or before 05th September, 2024 (closing date of application). The date of passing the examination which is reckoned for eligibility will be the date of passing appearing on the marksheet and Provisional certificate.
- 3. Candidate should indicate the percentage obtained in Graduation calculated to the nearest two decimals in the online application. Where CGPA / OGPA/ CPI is awarded, the same should be converted into percentage and indicated in the application form. The Conversion Formula is to be uploaded in the online application in such cases. It shall be the responsibility of the candidate to produce conversion formula to percentage duly issued by concerned University/ Institute at the time of Interview, failing which the candidature is liable to be rejected.
- 4. Calculation of Percentage: The percentage marks shall be arrived at by dividing the marks obtained by the candidate in all the subjects in all semester(s)/year(s) by aggregate maximum marks in all the subjects irrespective of honours / optional / additional optional subject, if any. This will be applicable for those Universities also where Class / Grade is decided on basis of Honours marks only. The fraction of percentage so arrived will be ignored i.e. 59.99% will be treated as less than 50%.
- 5. All computations of age, qualification, experience etc. shall be done as on 05th September, 2024 (closing date of application) and all candidates are advised to apply only if they are of eligible age (including relaxation). 


