- 3. There is no provision for re-employment after termination of the project. The selected candidate will not have any right for claiming pay scale or absorption against any regular post being vacant on a later date at this institute.

The candidates selected for the written-test-cum interview should bring an application with full bio-data addressed to the Director, ICAR Central Tuber Crops Research Institute, Thiruvananthapuram with duly-attested photocopies of certificates and mark sheets (from SSLC onwards), experience certificates, publications/additional qualifications related to the job. A recent passport size photograph should also be affixed on top of the application. The applicant must produce his/her original documents prior to the written test.

- 6. No TA/DA will be paid to any candidate to attend the written test/ interview.

- 8. The candidates are requested to be present 60 minutes before reporting time on the date of written test cum interview for completing necessary official formalities and verification of documents.
