

3. Candidate must fulfill requisite qualifications/ conditions on the last date of receipt of applications i.e. on **08.08.2025** for candidates from Non Tribal Areas and on **23.08.2025** for tribal areas and abroad.
4. The engagement to the above post(s) shall be governed by the provisions of guidelines issued vide Department of Personnel's letter No. PER(AP)-C-B(15)-3/2024-Loose dated 14.05.2025 read with letter of even number dated 15.05.2025, further adopted and notified by this University vide Notification No. QSD. 4-8/CSKHPKV (GA)Vol. IV/- 23757-856 dated 05.06.2025.

If suitable candidate(s) belonging to Economically Weaker Section is/are not found, the vacancy(s) earmarked for EWS will be treated as de-reserved and will be filled up from a non-EWS candidate of unreserved category. 
