- 4. The candidates are permitted to converse either in ENGLISH or in HINDI during the Interview.





List of original documents to be submitted on the day of Interview:

- (i) Photo Identity Proof issued by any Government Authority i.e., PAN Card/Aadhaar Card/Passport/Driving License/ Voter ID etc.
- (ii) Matriculation/10th Standard or equivalent certificate indicating date of birth, or mark sheet of Matriculation/10th Standard or equivalent issued by Central/State Board indicating Date of Birth in support of their claim of age. Where date of birth is not available in certificate/mark sheets, issued by concerned Educational Boards, School leaving certificate indicating Date of Birth will be considered (like in case of Tamil Nadu, Kerala, etc).
- (iii) Candidate claiming change in name: The candidates should ensure that in case of any change in name or any discrepancy between name recorded in the Matriculation/other certificates/documents and the application (such as spelling error or due to addition/deletion of part of any name or when name of the candidate is inclusive of the name of father and/or mother), an affidavit in ORIGINAL is required to be produced at the time of interview that both the name/names in both the certificates belong to one and same person.
- (iv) All the candidates have to bring with them their ORIGINAL CERTIFICATES of all educational qualifications obtained by them, all mark-sheets there-of (semester-wise, year-wise), Date of Birth, all certificates of experience(s) gained by them, Patent(s), their Caste/ Community/ EWS certificate, etc, (in the prescribed proforma), copies of publication(s) substantiating their claim made in their application form and four (04) color photographs of the same photo which has been affixed or uploaded in the application form. In addition, the candidates should also bring two set of SELF-ATTESTED photocopies of all the afore-mentioned certificates/ documents.
- (v) Document/ Certificate furnished in a language other than Hindi or English, must be accompanied with an English Transcript of the same duly attested by a Gazetted Officer or Notary.
- (vi) Candidates who fail to produce satisfactory proof of qualification/ experience and other requisite documents, shall not be allowed to attend the Interview.
- (vii) The candidate who has submitted OBC(NCL) certificate in the prescribed proforma as applicable for employment under the Govt. Of India, but if the same is more than three-year old as on the last date of receipt of online application, they have been considered provisionally, subject to production of valid OBC(NCL) certificate (in the prescribed proforma) as applicable for employment under Govt. of India. In addition, they will also have to furnish a declaration that they belong to OBC(NCL) as on the last date of receipt of online application before appearing for Personal Interview.
- (viii) PwBD certificate in "prescribed proforma" issued by the competent authority by PwBD persons eligible for benefit in appointment to the post on the basis of prescribed standards of Medical Fitness.

- You are advised to bring your publications, books, manuscripts etc. the authorship of which you claim, and/or any Thesis/Dissertation submitted for postgraduate/Doctoral qualification, reprints of papers published in journals of repute, any literary/artistic and architectural work done by you which may have relevance to the advertised post and which you may wish to submit to the Interview Board for their scrutiny.
- Every candidate will be required to sign a phot-bearing attendance sheet before the commencement of their Interview.
- The candidature of candidates is PROVISIONAL subject to their being found 4. eligible in all respects.
