 - e) **PWD (Persons with Disabilities) Certificate** from the Competent Authority, if applicable, in GOI format.
 - f) **Diploma/Certificate in X-Ray Technician / Radiography course along with year-wise marksheets.**
 - g) **Experience Certificate(s)** for requisite period of 1(one) year.
 - h) **No Objection Certificate (NOC)** from his/her present Employer (in case of Govt./Semi-Govt./PSU/Statutory organization).
 - i) 4(Four) recent passport size colored **photographs** duly self-attested.
 - j) **Identity Proof** (PAN card/ Passport/ Driving License/ Voter ID card/ Aadhar Card, etc).
 - k) Documents / Certificates in support of any other additional qualification / experience mentioned in the application.
