**5. Important Information:**

- 5.1 The engagement will be purely on contract basis as per the policy of National Mental Health Program. The contract is extendable based upon approvals received from Govt. of India and annual performance evaluation. The scrutiny of application will be carried out by the institution on the basis of working experience of individual based on past record and interaction with a committee of the Institution.

- 5.2 There shall be an initial assessment (probation) period of three months from the date of first engagement.
- 5.3 No TA/DA shall be paid for attending the interview/skill test.
- 5.4 Eligibility Criteria for the above posts (Academic qualification, Experience, Remuneration, Age, etc.) is annexed below.

- 6.1 Applicant needs to register online for seeking eligibility for the interview.
- 6.2 For the interview, applicant needs to fill the in prescribed application format. Use CAPITAL LETTERS for filling the application format. The registration number generated online should be mentioned on application form.
- 6.3 Attach two Passport Size Photographs (one photograph paste and one staple with application form).
- 6.4 Name and Code of the post should be clearly stated in the application form in capital letters.
- 6.5 Self attested copies of following documents should be attached with the application form :

  - III. Marks Sheets & Certificates of Essential Educational Qualifications
  - IV. Marks Sheets & Certificates of Desirable Qualifications, if any.

  - VI. Caste Certificate/ PWD Certificate (if applicable)

- 6.6 **While coming for the interview, candidate will bring all self attested copies of documents as mentioned in para 6.6 above along with all the original documents (in physical) for verification of age and fulfil the eligibility criteria as per recruitment rules. Request for verification of documents on later date shall not be entertained. In case the candidate is not carrying original documents, he/she will not be allowed to appear for the interview. The application form will be rejected in case it is found incomplete or misleading in any respect.**
