

- 4) Applications received after 9.30 am will not consider. Attendance of the candidate will be taken at 9.30 am.
- 5) The eligible candidates will be interviewed by selection committee.
- 6) All certificates will have to be produced in original at the time of interview.
- 7) No TA/DA shall be paid to the candidates appearing for interview.



- 8) The selected candidates will be required to give an undertaking on stamp paper worth Rs.100/- that he/she will not leave job during the appointment period and shall complete the assignment and he/she will not claim for appointment on regular basis.
- 9) The candidates will be appointed for 11 months period (or less than that as per project duration).
- 10) Candidates should note that they should submit application to the office of College of Forestry, DBSKKV, Dapoli and interview will be conducted in the office of College of Forestry, DBSKKV, Dapoli.
