Qualification: - MBBS from recognized university/institution and must possess valid Registration Certificate from Delhi Medical Council. The candidate having completed compulsory rotatory internship within 02 years of date of interview shall be given preference.

Pay Scale:- As per pay matrix of level 10 (Rs.56,100 - 1,77,500/-) plus allowances as admissible under the rules.

Age:- 30 yrs for General [5 yrs relaxable for SC/ST, 3 yrs relaxable for OBC and 5 yrs extra relaxable for Persons with disabilities (Divyangjan) candidate] as on date of interview.

Tenure:- The maximum tenure of junior resident is for a period of one year only including any service rendered as junior resident earlier on ad-hoc /regular basis in any recognized institution.
