- 4. No Private Practice is allowed during the tenure of service in ESIC.

#### **Terms of Contract:**

Selected candidates shall be appointed on contractual basis initially for a period of one year extendable by another two years on the basis of satisfactory performance or till the joining of regular incumbent / faculty, whichever is earlier.

1.
