- 5. Candidates who have already completed Senior Residency for 3 years in any Central Institutions are not eligible for the post of Senior Resident.
- 6. Private practice of any kind will not be allowed except for Part time Superspecialists/Part time Specialists.
- 7. No TA/DA will be admissible for Interview.
- 8. Vacancies indicated above may change as per actual requirement on the date of interview.
- 9. Canvassing in any form shall be a disqualification.
- 10. The Selected Specialist/Super Specialist must have a professional indemnity policy which should cover the period of contractual engagement. The policy is meant to cover professional liability falling on them as a result of error and omissions committed by them while rendering professional services.
