Terms & Conditions:-

- Reservation for SC/ST, OBC,PwBD and EWS as applicable in Government of India (GoI) will be followed. Candidates who do not submit the requisite supporting documents in specified format will be treated as belonging to the unreserved category.
- 2. **Age Criteria:** Minimum 18 years and maximum 26 years as on the closing date of the application.
- 3. Age relaxations as per Government of India guidelines as applicable to apprentices.
- 4. **Stipend**: Apprentices are eligible for a monthly stipend as per the provisions of the Apprentices Act for the duration of their engagement.
- 5. **Selection:** Shortlisting and screening will be based on marks obtained in the respective qualifying examination, after which shortlisted candidates will be called for a test/interview, and the final merit list will be prepared based on their performance in the test/interview.
- 6. **Duration:** The duration of apprenticeship training will be one year.

7. General Conditions:

- I. Candidates are advised to carefully read the full notification for details of eligibility criteria and selection modalities before submission of application.
- II. Apprentice Registration:
 - a. Candidates shall have a valid NAPS/NATS registration number.
 - b. In case candidate is yet to register, please visit https://apprenticeshipindia.gov.in or NATS portal at https://nats.education.gov.in as relevant, and register
 - c. The registration details shall be submitted prior to verification process at Test/Interview.
 - d. The application Form (filled up MS Word file saved as non-image) shall be emailed to careers@fcriindia.com with Subject line "ITI Apprenticeship (Trade) or "Graduate Apprenticeship(BA/BSC/B.Com)
- III. The number of Apprenticeship slot shown is indicative/tentative.
- IV. During the period of apprenticeship, candidates will be governed by the Apprentices Act, 1961 (as amended in 1973 and till date) and the policies/rules of the organization.
- V. Upon completion of the apprenticeship period, FCRI shall have no obligation to offer employment on contract or regular basis or any other to the apprentices, nor can an apprentice claim any preferential right to employment on the basis of completing the apprenticeship at the institute.
- VI. The decision of the management will be final and binding regarding acceptance or rejection of applications, cancellation of the selection process in whole or in part, etc. and no correspondence will be entertained in this regard. Details / status will be posted on website and candidates may periodically check the website.
- VII. No correspondence regarding non-selection or non-issuance of call letters or such will be entertained.

- VIII. Candidates applying for more than one discipline will not be considered, and their applications will be rejected.
- IX. No Application Fee is charged.
- X. The candidature of the applicant will be provisional, subject to verification of all certificates and submission of a Medical Fitness certificate from a Government Medical Officer/Board at the time of joining.
- XI. The candidates should NOT have undergone Apprenticeship earlier or pursuing Apprenticeship Training as per the Apprentices Act, 1961, (as amended from time to time).
- XII. Candidates who have undergone training or have job experience of one year or more after attaining the prescribed qualifications shall not be eligible for engagement as apprentices.
- XIII. The applicant should not have completed three years after passing qualifying examination as on the closing date of applications; if the mark sheet does not mention the date of result declaration, the candidate must submit a certificate from the Principal of the college/institute stating the date of result publication at the time of document verification
- XIV. Applications or registrations that are incomplete or do not meet the eligibility criteria shall be treated as rejected.
- XV. At any stage of the selection process, of after the selection if a candidate is found to have furnished false or incorrect information, their candidature or engagement shall be liable to cancellation without further notice.
