Roles and Responsibilities

The domain expert shall provide GRSE with:

(a)high-level domain knowledge critical for optimizing hull designs, improving fuel efficiency, and ensuring compliance with evolving maritime regulations.

(b)Strengthen GRSE's R&D ecosystem, support innovation in ship hydrodynamics, and elevate design practices to global benchmarks.

(c) Lend credibility to GRSE's technical proposals in competitive bids, facilitate collaboration with premier academic and research institutions, and he should act as a mentor to in-house designers—thereby ensuring sustained knowledge transfer and technical capacity-building.

(d)Serve as a catalyst for positioning GRSE as a design-led, innovationdriven shipyard capable of delivering both defence and commercial vessels that meet international standards of performance, safety, and sustainability.

Contract Period: The contract will be for twelve months which can be further extended by a period of up to one year at a time or till the completion of assignment (whichever is earlier). The engagement will automatically cease on expiry of the said period unless it is extended in writing.

<u>Attendance & Working Hours</u>: The Domain Expert is required to provide over all guidance and support to expand the business horizon of the shipyard especially in new fields and emerging ship design technologies. Continuous physical presence in the shipyard is not considered necessary as most of these activities can be carried out through video calls, targeted physical meetings and emails as appropriate Therefore, physical attendance in the shipyard of up to 5 working days each month is considered adequate.

General Instructions / Other Terms & Conditions:

1. GRSE reserves the right to fill up the post based on suitability or increase/decrease the number of posts to be filled up or cancel any post or even cancel the whole process of recruitment without assigning any reason.

2. Short listed candidates will be called for interview. Candidates called for interview will not be paid any TA/DA.
