## **General instructions to the candidates appearing for the Written Test.**

1. Verification of certificates and relevant documents will be conducted if you qualify in the written test. You are therefore required to bring all your original certificates along with one set of Self attested copies of the certificates in support of your Educational & Technical Qualification, Age, Experience, Caste/Tribe/Community Certificate, Economically Weaker Section (EWS) Certificate, Disability Certificate, Ex-Servicemen (Copy of Discharge Book) etc. failing which, you will not be permitted to appear for the Skill/Trade Test and your candidature will stand rejected, thereby no traveling expenses will be reimbursed.
2. Candidates are advised to once again ensure that he/she fulfils the eligibility criteria and other conditions mentioned in the advertisement before the test.
3. If you are employed, service certificate / last pay drawn certificate / pay slip to be produced at the time of Document Verification.
4. Outstation candidates who qualify for the Skill/Trade Test after Document verification will be paid to and fro second sleeper class rail fare by shortest route from their nearest railway station (as registered by them in the Online Application System) to Goa Shipyard Limited only on production of proof of journey (Hard copy of Tickets) as per rules of the Company. Further in case of non-submission of any of the documents mentioned, incorrect details mentioned in TA claim form and Non fulfillment of eligibility criteria as mentioned in the advertisement, reimbursement will not be processed and the candidate will be responsible for the same.
5. Payment of Travelling Allowance shall be made by RTGS (ECS) after completion of selection process. Candidate is requested to bring a copy of Bank pass book (First page of your Account details) and hardcopy of the ticket.
6. TA claim form is available on GSL website ([www.goashipyard.in](http://www.goashipyard.in)) under the heading of **“Notice Board – Careers - Advertisement”**. Candidate is requested to download and submit filled TA claim form along with original tickets, Bank pass book copy and proof of Tribe/Caste/Disability/EWS certificate with self attested copy. Further in case of non-submission of any of the documents mentioned, incorrect details mentioned in TA claim form and Non fulfillment of eligibility criteria as mentioned in the advertisement, reimbursement will not be processed and the candidate will be responsible for the same.

You are advised to bring print out copy of online application, a copy of this call letter, along with ID proof i.e Voter ID / Driving License / Passport / Aadhar card / 03 colored photographs copies etc. and a set of photocopy of all document in support of age, caste, qualification, experience, etc failing which you will not be allowed to appear for Skill/Trade Test.
8. You may answer the test in Hindi or English. Candidates who want to answer the test in Hindi are requested to inform in writing to the company 03 days before the written test.
9. Any kind of Communication/Computation devices i.e. Mobile phone, Pager, Tablet and head set, calculator, etc. will not be allowed in examination centre.
10. If any candidate is found guilty of any act of misconduct during the examination, he/she will be disqualified from the selection process and no Travelling Expenses will be paid.
11. Those candidates who qualify in written test will appear for skill / trade test after document verification.
12. Written test will be held on **24.04.2025 (THURSDAY)**. Further Document Verification & Skill/Trade Test will be held on **24.04.2025 (THURSDAY)** and may extend subsequent day/days. Thus, if required; candidates have to make their own arrangement for boarding, lodging etc. for a day or more at your own expense.
13. Canvassing in any form will lead to disqualification.
14. Request for change in date, time and place for the written test / Document verification / Skill / Trade test shall not be entertained.
