Goa State Rural Livelihood Mission (Goa SRLM) is a society registered under Societies registration act, 1860 under the administrative control of Department of Rural Development and is implementing National Rural Livelihood Mission (NRLM) in the State of Goa. The primary objective of the mission is to provide sustainable livelihood to the women in rural areas of both the Districts by motivating and mobilizing the rural women into Self Help Groups (SHGs).

Goa SRLM will conduct Walk-in-Interview for the below mentioned posts purely on contract initially for the period of 2 years. 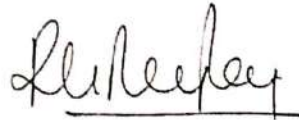
Terms & Conditions

1. Interested and eligible candidates possessing the essential qualification and experience can appear for walk-in-interview (as applicable) on the dates mentioned against each post along with the duly filled in, prescribed application form (attached).
2. Incomplete applications, application not submitted in prescribed format and application without supportive documents asked for, shall be summarily rejected. Qualification and experience should be in relevant discipline/field and from a reputed institution/organization recognized by relevant authority.
3. Separate applications should be submitted for each post, if applying for more than one post.
4. Experience shall be counted from the date of completion of minimum essential educational qualification. Submission of incorrect or false information during the process of walk-in interview shall disqualify the candidature at any stage.
5. The Goa SRLM reserves right to fill up or not to fill up the post advertised.
6. Candidate should write the Name of Project on the top of the application.
7. No benefit of Bonus, Gratuity & Leave Travel Concession, etc. will be considered, since the post is purely on contractual basis.
8. No TA/DA will be paid for attending the walk-in-interview.
