- i) Master 's degree with 55% marks (without including any grace mark procedure or rounding off) (or an equivalent grade in a point - scale wherever the grading system is followed) in **Library and Information Science** subject from an Indian University, or an equivalent degree from an accredited foreign university.
 - ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) in **Library and Information Science** conducted by the UGC or the CSIR, or a similar test in the same subject accredited by the UGC, like SLET / SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil. / Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET.
 - iii) Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye - laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions: -
 - a) The Ph.D. degree of the candidate has been awarded in a regular mode.
 - b) The Ph.D. thesis has been evaluated by at least two external examiners.
 - c) An open Ph.D. viva-voice of the candidate has been conducted.
 - d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal.
 - e) The candidate has presented at least two papers based on his / her Ph.D. work in conferences /Seminars sponsored / funded / supported by the UGC / ICSSR / CSIR or any similar agency.
