- 2. The process fee for the post of Medical Officer posts shall be **Rs. 300/-**. The draft of this process fee shall submitted along with the form. The draft shall be in favor of Registrar Hemchandracharya North Gujarat University, Patan.
- **3.** This post is purely on contractual basis and will be filled for maximum of 11 months or till the regular appointment made in Health Center, Whichever is earlier.
- **4.** Incomplete application in any respect will not be considered.
- 5. Applicants are advised to submit the documents related to their change of name (if applicable) (i.e. Marriage Certificate, Gazette for Name Change, Aadhaar Card).
- **6.** The experience and qualification will be reckoned as last date of submission of Application.
- 7. Applicants are advised to submit the applications to the University well in advance without waiting for the last date to avoid postal delay or any delay

- due to other unforeseen events or circumstances. The University shall not be responsible for any postal delay at any stage.
- **8.** Applicants must produce original testimonials, certificates / educational qualifications and other documents at the time of interview.
- **9.** The applicants must ensure that he / she fulfils the eligibility conditions for the post.
- 10. The University shall verify the antecedents and documents submitted by candidates at any time, at the time of appointment or during the tenure of service.
