The High Court of Andhra Pradesh issued notification vide Roc No.130/2024-RC on 16.02.2024 for appointment of 8 Law Clerks on contract basis to assist the Hon'ble Judges. In response to the said notification, the High Court received 215 applications. After scrutiny it is found that, only 123 candidates meet the eligibility criteria as per the terms of the notification. The applications which are found to be on correct lines, are shown in Annexure –I. So far as the other candidates concern, they do not fit the criteria as mentioned in the guidelines published along with the notification. Therefore their applications have been rejected Vide Annexure-II.

The applicants who found to be eligible for viva-voce are shown in Annexure – I, are directed to appear for Viva-voce on 19.04.2024, 22.04.2024 to 25.04.2024 as per the schedule. The applicants appearing physically are directed to approach Recruitment Cell, High Court of Andhra Pradesh at Amaravati, Nelapadu, Guntur District -522239 at 2.00 PM for verifications of documents, followed by viva-voce. The final year Law pursuing applicants, hailing from DSNLU, Visakhapatnam shall appear through virtual mode (contact Registrar of the University for further instructions) as per the schedule mentioned.

The applicants shown in schedule – V(A) (Sl.No. 1 to 8) have to appear through virtual mode [at their respective State High Courts(Law Graduates)/ Parent University(final year students)] accordingly as per the instructions given. The respective High Courts / Universities of the applicants have been addressed letters with a request to make necessary arrangements for conducting Viva-voce through virtual mode.

In case if there is no response from the respective High Courts/Universities, due to technical or related issues, the applicants have to appear physically before the High Court of A.P. in the dates shown in the schedule.
