Sports Eligibility

Candidates must be meritorious sportspersons satisfying the prescribed sports eligibility conditions. Relevant achievements in recognized competitions during the prescribed reckoning period will be considered.

Sports Achievement Reckoning Period: 01-01-2022 to 30-06-2026. Candidates should refer to the official notification for the exact eligible competition levels and prescribed sports certificate formats.

Selection Process

1. Scrutiny and shortlisting of applications based on eligibility and sports achievements.
2. Document Verification.
3. Ground / Field Proficiency Test.
4. Data Entry Skill Test for Tax Assistant candidates — 8,000 key depressions per hour.
5. Final selection on merit and medical fitness.
