## 2. **Description of duties**

(a) Post is of Sweeper/Safaiwala and duties includes maintaining hygiene, sweeping, Mopping, cleaning of drains, cleaning of toilets, maintenance of septic tank/sewer lines/Bathrooms onboard Indian Coast Guard Ships, Shore establishment premises.

(b) Post is transferable anywhere in India (Mainland/Islands) subject to exigencies of the service.

## 3. **Physical Standards** Following are the requirement of physical standards:-

(a) <u>Height</u>. Minimum height requirement is 157 cms (which may be reduced up to 5 cms in the case of Nagaland, Mizoram, Meghalaya, Arunachal Pradesh, Manipur, Tripura, Garhwal/Kumaon, Sikkim, local tribals of Andaman & Nicobar Islands and upto 2 cms in case of candidates from Lakshadweep, mainland settlers in Andaman & Nicobar for candidates joining the Coast Guard).

(b) **<u>Chest</u>**. Should be well proportioned. Minimum expansion 5 cms.

(c) <u>Weight</u>. Proportionate to height and age ( $\pm$  10% acceptable).

(d) **Eye Sight**. 6/60 (Better) 6/60 (Worse) without glasses. 6/9 (Better) 6/24 (Worse) with glasses.

4. <u>**Recruitment Procedure**</u> The following selection procedure will be followed for recruitment of Enrolled Followers: -

(a) **Document verification (Pass/Fail)** Following Original documents (also 02 self-attested photo copies) will be checked during the documents verification on examination day:-

 (i) Matriculation (10<sup>th</sup>) or equivalent Certificate or
 ITI Certificate (if applicable).

(ii) Age proof certificate (Birth Certificate or 10<sup>th</sup> certificate with date of birth) Unserved candidates are to be born with date of birth between **31 Jan 2000 to 30 Jan 2007** (both dates inclusive) and three years age relaxation in case of OBC candidates would be admissible as per existing Govt rules.

(iii) Caste certificate (if applicable) issued by the competent authority (As per **Enclosure II** to this letter). Failure to produce caste certificate as per attached format for appointment for the post of Govt. of India will lead to cancellation of candidature.

(viii) Character certificate as per **Enclosure IV** to this letter (Character certificate is not required with application but the character certificate is required when appearing for written test). Hence, candidates are directed to prepare the character certificate without waiting for the call letter.

(ix) Any one of Proof of Photo ID like Aadhar Card or PAN Card or Voter ID Card. The proof of Photo ID card name and other details has to match with all the other certificates and documents submitted for documents verification. Any Mismatch in any document submitted will lead to cancellation of candidature.

(x) Ink signed call letter sent for written test and selection process.

(b) **Written Test**. All eligible candidates shall appear in a written test (50 Marks) comprising of General knowledge and General English (level of 10<sup>th</sup> standard). The duration of written test is one hour. The pass marks will be 50% for the General and OBC candidates and 45% for SC/ST candidates. Only those who qualify in the written test will appear in the "Professional Skill Test".

(c) **Professional Skill Test (PST)**. The PST will be of Qualifying/Not qualifying nature ('Q/NQ'). The skill test shall consist of following activities and one shall qualify in each activity,

(d) **Physical Fitness Test (PFT)**. All those candidates who have qualified both in the Written Test and Professional Skill Test will have to qualify the Physical Fitness Test (PFT) on the same day or on the next day. The PFT will be of qualifying nature ('Q/NQ'). The standards for PFT are laid down below:-

- (i) One mile /1.6 Km run Within 07 minutes
- (ii) 20 Squat ups (Uthak Baithak)
- (iii) 10 Push ups

(e) <u>Medical Standards</u> Candidates who qualify in written, PST and PFT will be subjected to a medical examination as per medical standards for Indian Coast Guard.

(f) **Body Tattoo** Permanent body tattoos are not permitted on any part of the body. However, certain concessions are permitted to candidates belonging to tribal areas communities as declared by the Govt. of India. For other candidates, permanent body tattoos are only permitted on inner face of forearms i.e. from inside of elbow to the wrist and on the reverse side of palm/back (dorsal) side of hand.

5. **Pay Scale.** Rs. 21700/- 69100/- (Pay Level-03) and HRA, DA, Transport Allowance, Medical facilities and other applicable allowances as per central govt. rule.

6. In case of any injury/ accident occurred during the test and PFT/PST Government will not be held responsible for any compensation/allowance.
