#### 4. **Mode of Selection**

4.1 **Scrutiny of Applications.** All applications received from the candidates will be scrutinised subject to the eligibility criteria and necessary documents and the admit cards/call letters will be issued to the shortlisted candidates for document verification & appearing in the written examination.

4.2 **Document Verification.** All the shortlisted candidates will undergo document verification prior appearing in the written examination. Candidates will be required to bring their original documents including original Admit card/Call letters and self-attested Xerox copies (02 sets) of the same as per the directives / instructions given in their admit cards.

#### 4.3 **Biometric Data - Capturing and verification**

4.3.1 It has been decided to capture and verify biometric data (thumb impression) and photograph of the candidate during the process of recruitment at the time of document verification of before entering the examination hall.

4.3.2 Candidates whose biometric does not match at any stage of selection process, **will not be allowed** for written examination.

## 5. Important instructions to candidates.

5.1 Before applying for the post, the candidate should ensure that he/she fulfils the eligibility and other norms mentioned in the advertisement.
