6.	Desirable	M.D. or equivalent PG Medical qualifications with at least 60% marks in General Medicine.
7.	Experience	Candidates having experience will be preferred.
8.	Pay	Negotiable in between the range of Rs. 30,000/- to Rs. 60,000/- per month based on experience and qualifications.
9.	Duties	On visit basis; and up to a duration of 02 hours for each visit. At least 05 visits in a week including to IIPE Hostels.

- 12. The engagement will be on part-time basis, purely temporary in nature, initially for a period of twelve (12) months and further extendable by another 12 months, on mutual agreement by both the parties.
- 13. The engagement can be terminated with 30 days prior notice from either side.

- (ii) Verify the medical bills of the staff for correctness and to recommend for reimbursement of such bills as per Institute's policy/ CGHS norms.
