**Invitation of application for the temporary positions under WAPCOS Consultancy projects to be selected through Walk-in-Interview**

Applications are invited in the attached format from the eligible candidates for engagement against following 2 (two) purely temporary positions to be filled under the following two M/s WAPCOS Limited (A Government of India Undertaking, Ministry of Jal Shakti), Gurugram, Haryana-15 funded projects titled;

(1) Preparing Watershed Development Plan for micro watersheds within 10 km radius of the Kharag hydro-electric project at Kandhamal, Odisha and

5. The selected candidates are liable to be posted initially at ICAR - IISWC, Research Centre, Koraput but may also be posted in any place(s) as per the requirement of project without any extra payment except emoluments.
6. The essential qualification given in the advertisement against the posts is minimum. Candidates possessing higher qualification in the relevant fields may also be considered for the position subject to their suitability of the position.

They may bring all original certificates for verification at the time of reporting / interview.
8. No TA/DA will be paid for attending the interview or joining the position by the selected candidate.

10. The selected candidates should have good health and shall have to produce medical fitness and character certificates from two referees at the time of joining the position.
