1. Master's degree in Physical Education (M.P.Ed)/ Sports Sciences or equivalent with at least 55% marks with three (3) years of relevant experience in any recognized institution.

OR

Bachelor's Degree in Physical Education (B.P.Ed)/ Sports Sciences or equivalent with at least 55% marks with five (5) years of relevant experience in any recognized institution.

Essential Experience: - Should have participated at the State/ National level and; Should have specialization in at least one sport such as Hockey, Athletics, Swimming, Football, Basketball, Badminton, etc.

Desirable: - Having experience working in Centrally Funded Educational Institutes/Central Government/Autonomous Bodies/PSUs etc.

Age: - Upper age 35 years on the last day of application as mentioned in the advertisement.
