In pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examinations) Rules, 2022 read with Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, the candidates as per Annexure-A to this notification are hereby declared to have qualified for the Oral Test/Viva Voce for the posts of Assistant Engineers (Mechanical) in Public Works Department on the basis of their performance in the Written Tests which was held on 24.12.2022. - iii. Only eligible candidates, possessing requisite qualification prescribed under rules, shall be allowed to appear in the Oral Test/Viva-Voce subject to the condition that they are within the prescribed age limit on the cut-off date.
- iv. The candidates shall produce their original certificates/testimonials on the date of oral test/Viva-Voce.

This is subject to the outcome of writ petition, if any, pending disposal before any competent Court of Law.
