JNPA invites application for recruitment of two fresher graduates in commerce on contract basis for a period of 3 years on following terms and conditions:

## Eligibility for fresher graduate

- 1) Should have a degree of graduation in commerce field
- 2) Age should be below 35 years as on 31st August 2022.

#### Remuneration

- 1) Remuneration will be Rs.25,000/- per month for fresher graduate with 10% increment based on good performance and 1 day paid leave per month.
