A selection for the one post of Teaching Assistant in Department of Veterinary Epidemiology & Preventive Medicine on daily wage basis is hereby notified at the College of Veterinary and Animal Sciences Pookode,Wayanad for a maximum period of 12 months.

### **I) Qualifications:**

1.Good academic record as defined by the concerned University with at least 55% marks (or an equivalent grade in a point scale wherever grading system followed) at the Master's Degree Level in the relevant subject from an Indian Veterinary University or an equivalent degree from an accredited foreign university.

2.Must have passed a Comprehensive Test in the concerned subject specifically conducted for the purpose by UGC or any agency duly constituted by the state government in this behalf.

**Note: i)**For SC/ST Candidates,Differently abled categories and for Other Backward Classes (OBC) (Non Creamy Layer categories) Minimum 50% marks for Bachelor's as well as Master's Degree shall be sufficient (as per UGC regulation on minimum qualification for appointment of teachers,published on 18.07.2018) and this relaxation is also applicable to PhD holders who had been awarded their Master's Degree prior to 19.09.1991.

**ii)**As per University Grants Commission Regulation -2016, candidates who have obtained Ph.D Degree in the concerned subject are exempted from passing the NET examination.

**iii)** For recruitment to this post, Degrees awarded by the Universities recognized by UGC alone shall be considered.

**iv)**Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

v)In the case of difference in original caste/ community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate/ Community Certificate at the time of certificate verification.
