# I Educational Qualifications for the Post of RBI Chair Professor at Faculty of Commerce:

- A (i) An eminent scholar having a consistently Good Academic Record with Ph.D. Qualification(s) in Banking& Insurance / Economics/ Business Finance in the concerned/allied/relevant discipline and published work of high quality, actively engaged in research with evidence of Published Work with a Minimum of 10 Publications in the peer reviewed or UGC listed journals and a total research score of 120 as per the criteria given in UGC Guidelines Appendix II Table 2.
  - (ii) A Minimum of 10 years of Teaching experience in University/College as Assistant Professor/Associate Professor/Professor, and/or Research experience at equivalent level at the University/National level Institutions including with evidence of having successfully guided Doctoral candidate.
  - (iii) Contribution to educational innovation, design of new curricula and courses, and technology-mediated teaching learning process with evidence of having guided Doctoral candidates and research students.

OR

B. An outstanding professional, having a Ph.D. degree in the relevant/allied/applied disciplines, from any academic institutions (not included in A above) / industry, who has made significant contributions to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience.

Candidate should be preferably a full time Professor or at least an Associate Professor who has published works of high quality especially in area of 'Banking & Insurance' and or concerned/allied/relevant discipline, actively engaged in research and training as well as having 10 years' experience of teaching and/or research, including experience of guiding research in a leading academic institute or holding an equivalent position in a non-academic organization in the age below 62 years shall be eligible to apply. Chair Professor is expected to undertake research in the relevant field and publish papers in international/national refereed journals based on his/her research. Selected Candidate shall be also required to teach in academic programs being offered by the Faculty of Commerce. Chair Professorship is to be initially awarded for three years, subject to further extension as per RBI and University rules and subject to satisfactory performance. Candidate on deputation shall also be considered for the tenure appointment.

**Salary:** Academic Level 14 (as per 7<sup>th</sup> Pay Commission) with rationalized entry pay of Rs. 1,44,200/- (The case for salary protection shall be considered subject to approval from RBI)

#### II The general instructions for the post of RBI Chair Professor

- Only online applications with required uploaded enclosures will be accepted. Applicant should send one hard copy of the application on or before 21/10/2024 along with all self-attested testimonials, certificates and all supporting documents relating to Academic Performance Indicators (API) or else the application will not be considered. Applicant must produce original testimonials, certificates and other documents at the time of interview, if called.
- The Last Date for receipt of Online Application is fixed as 21/10/2024 till
  5.30 p.m. p.m. The Online Application Form is to be sent on the http://cc.msubaroda.ac.in/MSUBRecruitmentP/
- 3. Applicant should refer UGC guidelines of 18<sup>th</sup> July 2018 for Academic Performance Indicators (API) whichever is applicable before filling the application form.
- 4. A candidate who knowingly or will-fully furnish incorrect or *false particulars* or suppresses material *Information, will* be disqualified and if appointed will be liable to dismissal from service, without notice.
- 5. If any additional information is to be given, the information in separate sheet should be uploaded.
- 6. The candidate must possess the required qualifications at the time of last date fixed for *receipt* of online applications in the notification by the University i.e. **21/10/2024**
- 7. Canvassing *direct or indirect will* be a disqualification.
- 8. The posts which are reserved for special category, the candidate who does not *fall under* the said respective *category should* not apply.
- 9. If the number of candidates possessing minimum qualifications is *large*, the University reserves the *right* to short-list the candidates on the merit-based criteria for the purpose of calling for interview.
- 10. For the post of Professor API Score page is compulsory field to be filled up or else his/her application will not be considered.

- 11. For the post of Professor *Candidate* has to make presentation before the Interview in *front of Selection Committee*, where *staff of the Department concerned and all candidates* who are called for Interview will be allowed to remain present. The presentation *will* be for a maximum of 15 Minutes on the *topic of candidate's choice* in the subject concerned.
- 12. Candidates, if called for interview, will have to come at their own expense.
- 13. The University reserves the right to fill in or not to fill in any post or to alter the number of posts in any cadre or in any / all the subject or make any amendments.
- 14. Selected candidates may be posted in any Institution of the University.
- 15. The online application form fee is **Rs.1500/-** (**Rs.375/-** for SC/ST Candidates), that is required to be paid using Credit/Debit Card, or online banking only. This amount shall not be accepted in cash, through money order or postal order or through any other financial instrument except Credit/Debit cards. The aforesaid application fee is non-refundable and no enquiries shall be entertained in this regard.
- 16. Candidates already in employment in University, Educational Institutions, Government Establishments/ Organizations should upload the forwarding letter from present employers. However, due to any unavoidable circumstances if the application through proper channel is likely to be delayed, online application and hard copy will be considered as advance copy. The forwarded copy from the employer be sent separately. Persons employed after making application in response to this advertisement should bring a 'No Objection Certificate' at the time of interview from their employers.
- 17. Candidates must upload the self- attested copies of all MARKSHEETS and passing Certificates examinations in *which* he/she passed i.e. Higher *Secondary, Bachelor's* Degree/Master's Degree Doctorate etc. In absence of the attested *copies of Mark-sheets/Certificates etc., application will be considered incomplete* and applicants may not be called for interview.
- 18.A salary certificate showing Pay, D.A. and other allowances being paid by their Institution/Office/ Firm should be produced at the time of interview.
- 19. The knowledge of English is compulsory.
- 20. Appointed teachers may be assigned other academic or administrative responsibilities in addition to their regular teaching and research.
- 21.In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after the issuance of appointment letter, the university reserves the right to modify/withdraw/cancel any communication made to the candidate.
- 22. The online application form fee is non-refundable and no enquiries will be entertained in this regard by the University.

- 23. Reservation of posts shall remain as per Government of Gujarat rules.
- 24. The Selected candidate will have to sign a contract with the University. This appointment shall be purely on fixed tenure basis for a period of **3 years** under a contract and the tenure shall be at the sole discretion of the Institutions and as per the requirements of the Institutions and shall be under strict review at all times. The Institution can discontinue the contract at any point of the time for any reason whatsoever with a notice period as set in the contract.

It may be noted that the selected candidate shall under no circumstances and at any point of time be considered as a permanent employee of the Institution or The Maharaja Sayajirao University of Baroda. The appointment can be further extended subject to funding agency approval and university rules and subject to satisfactory performance.
