2. The Candidate must not be less than 18 years and more than 40 years of age as on 01/01/2021. The upper Age limit is relaxable as per Govt. Rule.
3. Minimum Educational Qualification is class VIII passed and those who have passed H.S.S.L.C. examination shall not be eligible to apply for the post.
4. Candidates possessing any special skill will be given preference.

5. If any Candidate is found to have suppressed his/her educational qualification or given any wrong information at the time of applying for the post, his/her candidature shall be liable to be rejected.
