Selected YP-II will be engaged in activities pertaining to data analysis and compilation and their interpretation for GIS activities such as preparation of thematic maps on various aspects of soil suitability map generation. Besides, collection of other relevant primary and secondary data required for report preparation and report writing.
4. The YP-II has to report to Dr. Ashok Kumar, Project Investigator (PI) at ICAR-NBSS&LUP, Regional Centre, Delhi regularly or as per need.
