ENGAGEMENT OF BUILDING MAINTENANCE ENGINEER ON CONTRACT BASIS

National Cooperative Union of India (NCUI), an apex body of the cooperative movement registered under the Multi State Cooperative Societies Act, requires a Building Maintenance Engineer (on contract basis), preferably a retired civil engineer from central / state Govt., PSU, cooperative or any reputed institution who has a vast knowledge base for construction works, monitoring and repairing a variety of systems with a working experience in comprehensive maintenance planning for large office buildings . Adept at scheduling routine maintenance, responding properly to emergency calls and engineering in preventing repair and maintenance works.

The candidate with technical skills such as identification and solving of civil engineering problems, knowledge of design techniques, drawings, maps CAD / estimation software, application of MS-Excel in civil engineering, construction and management will be given preference.

The candidate is required to oversee maintenance and repair of civil works, electrical, plumbing, ventilation, HVAC, carpentry, painting and other building systems. He should organize, prepare and maintain accurate reports, records of inspections activities, write letters regarding compliance on specific issues and complete other written reports and records as needed. He must be able to communicate, read and write in English language.

Educational/Technical qualification:

The candidate should possess either a 3 years Diploma in Civil Engineering with an experience of minimum 15 years or holding a Degree in Civil Engineering with a minimum working experience of 10 years in any of the institutions mentioned above.

Well acquainted with associated computer skills such as MS-windows, MS Office suite, MS Project, auto CAD etc.

Remuneration:

The incumbent shall be given Rs.50,000/- per month in lump sum. However, the management has right to fix the remuneration of the incumbent keeping in view of his qualification, experience and ability. The incumbent will not be eligible for any other remuneration or facility.
